

**Apple Shopping Event 2019
Terms and Conditions**

Customers can receive an Apple Store Gift Card with the purchase of selected Apple products. Offer is valid at Apple Online Store and by calling **1800 92 38 98** for purchases, beginning on 29 November 2019 and ending on 2 December 2019, subject to the terms and conditions herein.

Promotion Period: The promotion runs between 29 November 2019 and 2 December 2019 (the “Promotion Period”), in Ireland (“Qualified Country”).

Qualifying Locations: Apple Online Store and **1800 92 38 98** (each a “Qualifying Location”). Eligible Products and Promotional Products (as defined below) must be purchased from a Qualifying Location in the Qualified Country. Only purchases and deliveries within the same Qualified Country are eligible.
