Annual Report on Corporate Social Responsibility (CSR) Activities FY24/25

1. A brief outline on the CSR Policy of the Company:

The Company's corporate social responsibility ("CSR") Policy obligates the Company to undertake specific CSR projects and programs, as approved from time to time by the Company's CSR committee, in accordance with the CSR Policy's pre-established categories. To that end, during the fiscal year ended March 31, 2025, the CSR committee implemented eight specific CSR programs in accordance with the CSR Policy. The programs involved, amongst other things:

- Supporting the Akanksha Foundation in the provision of high-quality education to low-income communities in Mumbai, Nagpur and Pune through, amongst other things, financial support for teachers, technology related support and digital learning & literacy programs
- Supporting The Akshaya Patra Foundation in the provision of school mid-day meals, and distribution of plates and glass tumblers, to children in Puducherry, Hubballi, Bengaluru, and Hyderabad; Supporting installation of solar power plants in Varanasi and Bhubaneshwar
- Supporting EnAble India in the provisioning of high-quality education, training and capacity building of people with visual impairment and low-vision, hearing impairment and persons with cerebral palsy through, amongst other things, financial support for training sessions, awareness building and by developing a moderated social network, benefiting disabled people across the country
- Supporting Pratham Education Foundation in the provision high-quality remedial education and job skilling for school dropouts in Tamil Nadu and Karnataka
- Supporting EPMBindi International Association (Barefoot College international) in the electrification of rural villages through the use of sustainable solar energy power generation, the provision of education to the children of these villages, and the promotion of women's empowerment through the training of "Solar Mamas" and "Solar Sakhis", across Rajasthan, Manipur and several other states.



- Supporting the Paperman Foundation of India in the establishment of a formal environment to enable informal and E-waste micro-entrepreneurs with the appropriate tools and health and safety measures in Uttar Pradesh for the dismantling and processing of electronic waste ("e-waste")
- Supporting the Applied Environmental Research Foundation in the conservation of environmentally-beneficial habitats, in particular mangroves in Maharashtra.
- Supporting WWF India in the establishment of a Material Recovery Facility with the appropriate tools, training and health and safety measures in Goa for the collection and processing of marine and plastic waste.
