## Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some, but not all, sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what Apple Financing LLC does.

#### What?

The types of personal information Apple Financing LLC collects and shares depends on the product or service you have with us. This information can include:

- · Social Security number and income
- · Account balances and payment history
- · Credit history and credit scores

When you are no longer our customer, we continue to share your information as described in this notice.

#### How?

### How does Apple Financing LLC protect my personal information?

To protect your personal information from unauthorized access and use, Apple Financing LLC uses security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. These measures also include technical, physical, and administrative safeguards designed to protect the confidentiality, integrity, and availability of your personal information.

## How does Apple Financing LLC collect my personal information?

Apple Financing LLC collects your personal information, for example, when you

- · open an account or apply for a loan
- · use your credit or debit card or provide account information
- · give us your contact information

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

## Why can't I limit all sharing?

Federal law gives you the right to limit only:

- · sharing for affiliates' everyday business purposes—information about your creditworthiness
- · affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.

### **Definitions**

### **Affiliates**

Companies related by common ownership or control. They can be financial and nonfinancial companies.

 Our affiliates include financial companies with Apple in their name, such as Apple Payments Inc., and others, including Apple Inc. and its subsidiaries.

#### **Nonaffiliates**

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

· Apple Financing LLC does not share with nonaffiliates so they can market to you.

## **Joint Marketing**

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

Apple Financing LLC does not jointly market.

### Other important information

If you are a California resident, we will only share your information with nonaffiliates if required to or permitted by California law, including if you provide your consent to the sharing.

If you are a Vermont resident, we will not share information we collect about you with affiliated or nonaffiliated third parties, except as permitted by Vermont law, such as to process your transactions or to maintain your account, or as authorized by you. We will not share information about your creditworthiness with our affiliates except with your authorization or as required or permitted by law.
